RESEARCH PROJECTS

Current Projects:

(Im)mobile Lives? The Detention and Deportation of South Americans from the U.S. ~ This multi-year project draws on recent social science research on migration industries to conceptualize what I define as the

“deportation industry,” i.e. the for-profit economic activity concerned with the processing and manufacturing of the “illegal” and deportable immigrant. The project focuses on two main aspects of the U.S. deportation industry: 1) the complex political and economic organization and moral economy of this growing prison-industrial complex and 2) the impact of the deportation industry on detainees, their families, and local communities in the U.S. and in Latin America (Ecuador and Peru). The project expands on my prior work on transnational mobility in Peru and include ethnographic work with detainees in New Jersey detention centers, their family members in NJ, Peru, and Ecuador; NGO workers who cater to detainees/deportees and their families; U.S. immigration law enforcement officers as well as Ecuadorian and Peruvian government officials. The project’s pilot phase was a part of the Aresty Student Research Program at Rutgers University in 2014/15. The Ecuadorian portion of the fieldwork for the project was carried out in collaboration with sociologist Gioconda Herrera from FLACSO-Ecuador (2016-2018). The Peruvian portion of the research was carried out in Lima and El Callao between June 2018 and January 2019.

Engineering the Caribbean ~ This multi-year research and film project surveys how the built environment of the Caribbean also houses histories of race, violence, and various forms of mobility. It reconstructs the Caribbean as a space of skilled labor and knowledge flows by exploring the life and laboral trajectory of Juan Vicente Dinzey Hazle, a 87-year-old black Dominican “cocolo” civil engineer of West Indian descent. His life’s journey traverses the ruins/remnants of a sugar mill (Ingenio Consulo) in a West Indian enclave outside of San Pedro de Macoris in Dominican Republic where he grew up and labored as a child, to technical training as an engineer in Santo Domingo in the 1950s amidst political dictators and unequal racial landscapes, and later migration to New York City in the mid-1960s and Puerto Rico in the 1970s where he settled and continued building. The project is conceived in collaboration with Dr. Zaire Dinzey-Flores (LCS/Sociology, Rutgers U). The projected outcome of the project is an ethnographic/documentary film and a series of essays about multi-modal ethnography and interdisciplinary collaboration. The footage for the film is shot in Ingenio Consuelo (San Pedro de Macoris) and Santo Domingo in the Dominican Republic; in Ponce, Puerto Rico, and in various locations across New York City between 2016-2020. In its critical perspective and running commentary on race and the built environment in the Caribbean through Juan Dinzey’s interventions, the film is also a story of *cocolo* mobility in the face of constant demands to cross or subvert social and racial barriers.

Completed Projects:

Migrant Detention, Deportation, and COVID-19 Transmission: Public Health and Safety Challenges in New Jersey, 2020-2021. Growing evidence reveals institutions of confinement are ill equipped to manage public health challenges associated with COVID-19. Prescriptive guidelines like social distancing and the prohibition of large gatherings are structurally incompatible with the carceral infrastructure of jails, prisons, and detention centers. An early epicenter of the COVID-19 pandemic, New Jersey is also a key site of immigrant detention, where approximately 2,000 migrants are confined as they await adjudication in NJ and New York City-based immigration courts. This project examines empirically whether and how institutions of confinement serve as vectors for COVID-19 transmission, with an emphasis on the impacts of New Jersey-based processes of migrant detention and deportation on measures of coronavirus transmission. Through a mixed methods case study that incorporates statistical analyses, content analysis of policy and media reports, and remotely-conducted interviews with key informants, this NJ based case study will be used to further understandings of the intersection of immigration detention, deportation, public health, and COVID-19; and to pursue extramural funding for advanced research on the nexus between immigration and pandemic policy. The project is funded by the Center for COVID-19 Response and Pandemic Preparedness (CCRP2) at Rutgers University. It is a collaboration with K. Sebastian León (Latino & Caribbean Studies and Criminal Justice, RU-NB) and Sarah R. Tosh (Sociology, Anthropology, and Criminal Justice, RU-C).

Transnational New Jersey (TNJ), 2011-2013. Rutgers University. Co-PI with Daniel Goldstein (Anthropology-Rutgers). Funded by a collaborative research grant from Rutgers University. This project unified research, teaching, and public service into an innovative project that studied the impacts of global migration and transnationalism on local societal change. TNJ focused on New Jersey’s position as a rich nexus of geographical, cultural, and political-economic processes. The project brought together faculty and students of the SAS Social

and Behavioral Sciences and Area Studies Centers to explore and understand – through comparative, interdisciplinary conversation and study – the varieties of change occurring under the rubric of immigrant transnationalism, as part and parcel of contemporary global reality unfolding in, but in no way limited to, the small towns and suburbs of New Jersey. The project articulated with several University initiatives and commitments to enhance the support for programming and research on migration (Office of VP for Research), building global partnerships as well as domestic service-learning opportunities (GAIA), integrating students into faculty research (ARESTY), and fostering community engagement (Community-University Research Partnerships; CESEP).

Rutgers Immigrant Infrastructure Map (RIIM), 2009-2011. Rutgers University. Co-PI with Janice Fine (PI), Robyn Rodriguez, James DeFelippis, Kathe Newman, Christine Thurlow Brenner, Mara Sidney, David Tulloch, and Anastasia Mann. This project's goal was to inventory, categorize and map the non-governmental organizations operating in the state that are critical to the complex process of immigrant integration in New Jersey. The project was based at the Eagleton Institute of Politics and funded by an Excellence Grant from Rutgers University and additional grants from the Carnegie Corporation and the Fund for New Jersey.

Mediating Self and Community: Membership, Sociality, and Communicative Practices in Peruvian Migration to the United States, 2004-2005. New York University. Dissertation research project funded by the Wenner-Gren Foundation for Anthropological Research; McCracken Fellowship, NYU; and the Danish Social Science Research Council. This project examined the role of communicative practices in shaping social cohesion in the context of contemporary migration between Peru and the United States. By comparing older techniques of “community-production”, including compadrazgo and membership in *cofradías* devoted to saint's images, with newer ones including internet communication, phone calls, and circulation of videos, the project explored how US-based migrants and their families in Peru engage in long-distance maintenance and reproduction of social ties and accomplish social obligations in various locales.

Place and Mobility in the Peruvian Andes, 1998-2000, University of Copenhagen. Funded by the Månsson Foundation, the University of Copenhagen's North-South Research Grant, and the Department of Anthropology, University of Copenhagen, this project focused on the intersection of place and mobility in shaping the experiences of rural-to-urban and transnational return migration in highland Peru and among migrants in Lima. The research was the basis for my award-winning MA thesis titled *Locating Matahuasi: Place and Mobility in Andean Peru* (University of Copenhagen, 2001).
